Location: Newburyport High School, 241 High Street, Newburyport, MA. 01950

Show times: Doors open at 9:30AM and show starts at 10:00AM (live judged, means no separate pre-judging and finals. Group comparisons, individual routines and award presentations are done straight through. Expected end time is 8 PM)

Divisions: Men's Bodybuilding: Debut, Teen, Junior, Novice, Open, Masters 40+, Grand Masters 50+. Men's Physique: Open. Women's Bodybuilding: Open, Masters 40+. Ms Fit Body: Open, Figure: Debut, Novice, Open, Masters 40+. Bikini: Debut, Novice, Open, Masters 40+.

Division Details: Debut: First time competitors only. Teen: Age 19 and Under. Junior: Under age 23. Novice: Open only to those who have not placed first in any class besides Teen within any division in the same category with any organization (unless you were the only competitor in the class). Eligibility will be verified during polygraph testing. Masters Divisions: Open only to those falling into the stipulated age range. Open: Open to anyone regardless of age and level of experience. All Open and Masters 40+ class winners or overall winners qualify for WNBF Pro status (Meeting Class Number Requirements)!

Classes: Open bodybuilding classes will be filled based upon weight. All Novice, Masters, Classic, and Grandmasters will be split based on entries and determined on the day of the show. Open - Figure, Bikini, and Ms Fit Body classes will be filled based upon **exact** height. (ex. 5'3½" do not round up or down)

Crossovers: Are allowed only within each division. For example - Women may do Bodybuilding, Ms Fit Body, Figure, and Bikini as long as they are all in the same division. (open or novice) ALL athletes meeting the age requirement may compete in Masters or Grandmasters as well.

Check-in: Friday July 21th between 8am-7pm at host hotel: Hampton Inn-Amesbury, 284 Elm Street, Amesbury, MA 02193. Any competitors not reporting for check-in will be scratched from the show (All fees are non-refundable).

Fees: Registration fee - \$65. if postmarked by 6/27/2017, \$90. if postmarked after 6/27/2017. **Entry Deadline 07/16/2017. No Walk-ins.** Crossovers are \$25. per additional class. WNBF Membership is required \$63. (if not a current member). Polygraph Testing is \$50. payable directly to the examiner at the time of testing.

Tickets: Adult General Admission \$40. (Children under age 10 are Free), Trainers Ticket \$60.

Drug Testing: Polygraph testing for all competitors is \$50. payable in cash to the polygraph examiner at the time of testing. Photo identification required. If any competitors are not polygraph tested for the event they are ineligible to compete. Plus all competitors subject to additional forms of testing, if requested, at the discretion and expense of the promoter. Backstage policy: 1 trainer per competitor will be allowed, trainer MUST have a trainers pass (\$60.), which is good for General Admission and back stage access.

Routines: Routine length is 1 minute for bodybuilding. Music is to be provided on CD-R only. No profanity in music. Props allowed. Figure/Bikini competitors will use house music (provided) for stage walk and finals
